

**Ski and Stay Vacation Sweepstakes
Official Rules**

No purchase necessary to enter or win. **A purchase does not increase chances of winning. Only open to legal residents of the continental United States mainland who are at least 18 years of age. Void where prohibited by law.**

1. **HOW TO ENTER.** Between November 20, 2010 and January 31, 2011, consumers can visit <http://www.parkcityarealodging.com/enter.aspx> to register for a chance to win the Ski and Stay Vacation Sweepstakes. Entrants register for the sweepstakes by submitting the online registration form including name, home address, e-mail address, and telephone number. All entries become property of the Park City Chamber Bureau / Park City Area Lodging Association (hereafter known as Park City).

LIMIT: ONE ENTRY PER HOUSEHOLD.

2. **DRAWING.** All entries must be received by before 11:59 PM, MTN, Sunday January 31, 2011. Winner will be selected in a random drawing. The random drawing will be held on or about Tuesday, February 2, 2011 from all eligible entries received. By participating, entrants agree to the Official Rules and to the decisions of the judges, which shall be final and binding in all respects.

Park City will attempt to notify the winner by telephone and/or e-mail the same day of the drawing. If Park City is unable to notify the winner by telephone or if the email is returned undeliverable within 72 hours from the drawing, the prize will be forfeited and an alternate winner will be selected. Notification calls and/or emails will be made during normal business hours at the daytime phone number given at time of entry.
